## Program Overview

Your company has the opportunity to compete for honors in the construction industry's premier annual awards program – the ABC Eastern Pennsylvania Chapter Awards of Excellence competition – recognizing the outstanding merit shop projects of the year. Use this application and the included forms to enter your company's best project(s).

All award winners will be recognized at the Awards of Excellence Celebration at Presidential Caterers in Norristown on November 3, 2022. The ceremony will feature a multi-media presentation highlighting the Excellence and Merit winners, and an elegant, printed program highlighting each award-winning project.

## Judging Criteria

The panel of judges represents a cross-section of construction industry experts, including owners, architects, engineers, and industry leaders. The competition is comparative, using a points system to assist in the comparisons. A project entry can earn a total possible score of 100 points. Answers to questions should be clear and succinct as directed; the quality of an entry's presentation will have a great impact on its opportunity to win. Please use the checklist at the end of this document to review your entry prior to submittal.

Points will be deducted for grammatical errors, spelling mistakes, and typographical errors.

## Entry Requirements

Each entry must follow the entry requirements outlined in this award application. You may email questions to [aaldred@abceastpa.org](mailto:aaldred@abceastpa.org).

### ABC Membership

Only ABC members, in good standing, are eligible to enter.

### Project Safety Requirement

No project that involves prime, multi-prime or sub-trade contractors that has a safety-related fatality is eligible to be considered for an award.

### Completion of Project Requirement

To be eligible for 2022 award consideration, the project must have been substantially completed between September 1, 2021-September 1, 2022.

### Project Entry Steps

- 1. Entry Materials** – All project materials must be submitted to Amy Aldred at [aaldred@abceastpa.org](mailto:aaldred@abceastpa.org) no later than Friday, August 19, 2022. Submissions can be emailed or uploaded and submitted via Dropbox, Google docs, etc. Late materials will not be accepted, and your project may be disqualified.
- 2. Project Entry Fee** – Each project must be submitted with a \$500 entry fee check made payable to Associated Builders and Contractors of Eastern PA.
- 3. First-Time Entry Fee** – If your company has never entered this competition, your entry fee is \$350 for the first entry in 2022. Standard fees apply to any additional entries. Please e-mail the Amy Aldred at [aaldred@abceastpa.org](mailto:aaldred@abceastpa.org) about entrant history.
- 4. Judging Day** – Each project must have a knowledgeable representative on-site to meet with the judging team on September 8, 2022. The site representative must be able to answer detailed questions about the project. The judges will review project materials before arriving. You may have additional materials on-hand for the judges pertaining to the project.
- 5. Awards Gala** – Project awards will be presented at the awards gala on November 3, 2022, at Presidential Caterers in Norristown.

## 1. Project Information Form (PDF format)

## 2. Project Narrative (Word or PDF format)

Provide a written narrative indicating why this project is special and why it qualifies for an award. The focus of the narrative should be the construction of the project. Suggestions on what to include:

- Innovative programs related to quality control
- Innovative programs related to scheduling
- Value analysis/engineering process used in the project
- Special obstacles you overcame in completing the project
- Difficulties or extenuating circumstances you encountered in completing the project

The description may be up to two (2) pages, single-sided and can include photos.

## 3. Owner's Letter of Recommendation (Word or PDF format)

Include a letter of recommendation from the owner. If an owner is unable to provide a letter due to company policy, include a letter from the owner on its letterhead stating the owner is unable to provide a reference.

Specialty contractors must submit a letter from at least the general contractor if working under a general contractor. If not working under a general contractor, specialty contractors must submit a letter from the owner.

## 4. Safety Form (PDF format) (30% of your score)

## 5. Photographs (JPG or TIFF format)

You may submit up to **10** photographs of the project labeled PROJECTNAME1, PROJECTNAME2, etc. The photos can depict progress as well as the finished project. Photos must be high resolution and in JPG or TIFF format. Please label one PRIMARYPROJECTNAME – it must be a horizontal photo that will be used for promotional materials and any framed photos ordered.

## 6. Contractor/Supplier List (Excel format ONLY)

A list of all subcontractors and materials suppliers on each project must be included. The Excel template at <https://www.abceastpa.org/awardprograms> must be used to provide all the requested information. The list should include ABC and non-ABC members. The Submission that had the most ABC Eastern PA Members work on their project will be awarded the Champion of Merit Award. If the form is not received with your submission you will not qualify.

## 7. Project Address/Special Instructions – Submit the project address along with any special instructions or details the judging team should be aware of when arriving at your project, i.e., photo id required, parking restrictions, where to meet the onsite contact.

## 8. Description for Presentation (Word document)

Write a brief, 30-40-word description to be read aloud during the presentation at the awards gala. Please include phonetic pronunciation for any potentially challenging names, words, etc. Keep in mind when writing your description that it will be read live at the Awards Gala. The project name should be in the first sentence, so attendees know what project is being spoken about.
